Work with student to develop a plan for improvement</p>	<p>Discipline <u>may</u> include:</p> <ul style="list-style-type: none"> ▪ Loss of internet privileges for 30 days or more. ▪ Detention or extended school assignment ▪ Possible loss of credit or points due to inability to access the internet as needed to complete assignments.
<ul style="list-style-type: none"> ▪ <i>Circumventing safeguards</i> ▪ <i>Security breach</i> ▪ <i>Multiple A or B level infractions</i> 	<p>Level C: <i>Handled by Administrator</i></p>	<p>Step 3: Parent phone contact or conference dependent upon the violation.</p>	<p>Discipline <u>may</u> include:</p> <ul style="list-style-type: none"> ▪ Loss of network privileges ▪ ID card punched ▪ Possible loss of credit or points due to inability to complete course without network access ▪ Extended school assignment or suspension
<ul style="list-style-type: none"> ▪ <i>Harassment or Cyber bullying</i> ▪ <i>Continued infractions will be deemed defiance.</i> 		<p>Step 4: Some infractions may result in <i>suspension</i> or <i>expulsion</i>.</p>	<ul style="list-style-type: none"> ▪ Discipline plan will be developed pursuant to district policy #3241 as appropriate. ▪ Parent will be contacted by the administrator.
<p>***Severity of infraction could result in escalation of remediation level. Flagrant violations will result in immediate referral to administration. All other school and school district policies not addressed here are also imposed.</p>
